## May 11<sup>th</sup> 1936

The regular monthly meeting of the V&C of Christ Church was held in the infant church school room this evening at 8 o'clock immediately after a joint meeting of the Episcopal men's club. The V&C of the Church of the Advent held their meeting in the Parish House.

At our meeting there were present Dr. Dandridge, Mr. McCloud, 13 Members of the Vestry and 13 members of the Council. The Rev. Thomas P. Simpson, Deacon, who will have charge of the church's work at Old Hickory and three officers of the Old Hickory Mission Committee - Messrs. Dickson, Bogia and Swezey were also present.

The meeting was opened with prayer by Dr. Dandridge - who also acted as chairman. The rector read his report and copy is attached.

Mr. Simpson and members of the Old Hickory Committee were introduced by the Chair.

## July 13 1936

The July meeting of the V&C was held in the Parish House of Christ Church this eve at 8 o'clock. There were present the Rector, Dr. D., Mr. Thos. Simpson, in charge of the Church's work at Old Hickory and Messrs. Lambeth, Finnegan, Smith, Davidson, Tankard, Peck, Henkle, Brown, Nellums, Wright, Martin, Sr. Crandall, Howell, Dyer, Rogers, and LeSueur of the V&C.

The meeting was opened with prayer by the Rector who also acted as chairman. Upon call by the Chairman for reports, the Rector read his report and copy is attached.

Mr. Simpson made an oral report. He advised that he had baptized 3 children during the past month and thought that the work at Old Hickory was progressively splendid.

Sr. and Jr. Wardens had no reports to make. The treasurer Mr. Wright read his reports for May and June and copies are attached. Custodian Mr. Tankard submitted a written report and same is attached. Treas. of school Mr. Hormel read his report for May and Copy is attached.

Committee Reports - Dr. Dandridge made an informal report for the Laymen's Conference Committee stating that Bishop Bratton had advised that he could be at the conference in Sept.

It was moved, seconded, and carried that the conference should start with a meeting and supper in the country Sat. Sept. 19<sup>th</sup> and the details he left to the committee to work out.

It was moved, seconded, and carried that this committee should be enlarged and be given power to form sub-committees. The chair there upon appointed Messrs. Dyer, Hormel, Brown, and Peck as additions to the Laymen Conference Committee.

Mr. Nellums made an informal report for the Daily Peace Fund Committee.
