THIS AGREEMENT MADE THE TWENTY SECOND DAY OF JULY IN THE YEAR NINETEEN HUNDRED AND THIRTY NINE BY AND BETWEEN J. F. HOLT, DOING BUSINESS UNDER THE NAME OF W. F. HOLT & SONS, OF NASHVILLE, TENN., HEREINAFTER CALLED THE CONTRACTOR, AND J. O. TANKARD, ACT-ING SOLELY IN HIS OFFICIAL CAPACITY AS CHAIRMAN OF THE REMODEL-ING COMMITTEE OF AND FOR CHRIST EPISCOPAL CHURCH, OF NASHVILLE, TENN., HEREINAFTER CALLED THE OWNER,

WITNESSETH, THAT WHEREAS THE OWNER INTENDS TO ERECT INTERIOR ALTERATIONS WITHIN HEREIN DESIGNATED PORTIONS OF HIS RELIGIOUS EDUCATION BUILDING ON NINTH AVENUE, NORTH, NASHVILLE, TENN.,

NOW, THEREFORE, THE CONTRACTOR AND THE OWNER, FOR THE CON-SIDERATIONS HEREINAFTER NAMED, AGREE AS FOLLOWS:-

ARTICLE I. THE WORK TO BE DONE AND DOCUMENTS FORMING CONTRACT;

THE CONTRACTOR AGREES TO PROVIDE ALL THE LABOR AND MATERIALS AND DO ALL THINGS NECESSARY FOR THE PROPER CONSTRUCTION AND COM-PLETION OF THE WORK SHOWN AND DESCRIBED ON DRAWINGS BEARING THE TITLE "PLANS FOR REMODELING RELIGIOUS EDUCATION BUILDING OF CHRIST EPISCOPAL CHURCH, NASHVILLE, TENN.", DATED EVEN DATE HEREWITH, AND IN THE SPECIFICATIONS HEREINBELOW INCORPORATED.

THE SAID DRAWINGS AND SPECIFICATIONS AND THE GENERAL CONDI-TIONS OF THE CONTRACT (THE STANDARD A.I.A. 1937 FORM HEREIN RE-FERRED TO), TOGETHER WITH THIS AGREEMENT, CONSTITUTE THE CONTRACT.

THE SAID DRAWINGS AND SPECIFICATIONS HAVE BEEN PREPARED BY DONALD W. SOUTHGATE, NASHVILLE, TENN., THEREIN AND HEREINAFTER CALLED THE ARCHITECT.

ARTICLE 2. CHANGES IN THE WORK;

THE OWNER, THROUGH THE ÅRCHITECT, MAY FROM TIME TO TIME, BY WRITTEN INSTRUCTIONS OR DRAWINGS ISSUED TO THE CONTRACTOR, MAKE CHANGES IN THE ABOVE NAMED DRAWINGS AND SPECIFICATIONS, ISSUE AD-DITIONAL INSTRUCTIONS, REQUIRE ADDITIONAL WORK OR DIRECT THE OMIS-SION OF WORK PREVIOUSLY ORDERED, AND THE PROVISIONS OF THIS CON-TRACT SHALL APPLY TO ALL SUCH CHANGES, MODIFICATIONS AND ADDITIONS WITH THE SAME EFFECT AS IF THEY WERE EMBODIED IN THE ORIGINAL DRAW-INGS AND SPECIFICATIONS. SINCE THE COST OF ALL SUCH CHANGES, MAY, HOWEVER, AFFECT THE GUARANTEED MAXIMUM COST HEREINAFTER STIPULATED, NO SUCH CHANGE ORDERS SHALL BE MADE VALID WITHOUT A DETERMINATION OF WHETHER OR NOT THE SAID GUARANTEED MAXIMUM SHALL BE CORRESPOND-INGLY INCREASED SHOULD SUCH CHANGES INVOLVE INCREASED WORK. SHOULD SUCH CHANGES, IF OCCURING, AFFECT SAID MAXIMUM THEN THE AMOUNTS OF SAID INCREASES SHALL BE AGREED UPON AT THE TIME OR TIMES AND MADE A PART OF SUCH CHANGE ORDERS.

ARTICLE 3. CONTRACTOR'S DUTIES, STATUS AND GUARANTEE.

THE CONTRACTOR RECOGNIZES THE RELATIONS OF TRUST AND CONFI-DENCE ESTABLISHED BETWEEN HIM AND THE OWNER BY THIS AGREEMENT. HE COVENANTS WITH THE OWNER TO FURNISH HIS BEST SKILL AND JUDGEMENT AND TO COOPERATE WITH THE ARCHITECT IN FORWARDING THE INTERESTS OF THE OWNER. HE AGREES TO FURNISH EFFICIENT BUSINESS ADMINISTRATION AND SUPERINTENDENCE AND TO USE EVERY EFFORT TO KEEP UPON THE WORK AT ALL TIMES AN ADEQUATE SUPPLY OF MATERIALS AND CAPABLE WORKMENT AND TO SECURE ITS EXECUTION IN THE BEST AND SOUNDEST WAY AND IN THE MOST EXPEDITIONS AND ECONOMICAL MANNER CONSISTENT WITH THE INTERESTS OF THE OWNER.

ALTHOUGH THIS IS A "COST-PLUS-CONTRACT", UNDER TERMS HEREIN-AFTER SPECIFICALLY SET FORTH, THE CONTRACTOR AGREES AND GUARANTEES THAT THE TOTAL COST OF THE PROJECT TO OWNER, UNLESS MODIFIED UNDER ARTICLE 2, HEREOF, SHALL NOT EXCEED

THIRTY THREE HUNDRED FORTY EIGHT AND 62/100 DOLLARS (\$3,348.62);

IN OTHER WORDS THIS SAID SUM (\$3,348.62) SHALL BE GUARANTEED BY CONTRACTOR AS THE MAXIMUM SUM MADE PAYABLE BY OWNER TO CONTRACTOR, UNLESS MODIFIED IN WRITING AS ABOVE NOTED; AND THAT THE METHODS HEREINBELOW DESCRIBED FOR ARRIVING AT SUMS MADE PAYABLE SHALL BE SO LIMITED IN THE TOTAL AGGREGATE.

ARTICLE 4. FEE FOR SERVICES.

IN CONSIDERATION OF THE PERFORMANCE OF THE CONTRACT, THE OWNER, EXCEPT AS LIMITED BY ARTICLE 3, HEREOF, AGREES TO PAY THE CONTRACTOR, IN CURRENT FUNDS, AS COMPENSATION FOR HIS SERVICES HEREUNDER A FEE CALCULATED AT A RATE OF TEN PERCENTUM (10%) OF ALL COSTS PROPERLY INCURRED BY THE CONTRACTOR IN THE EXECUTION OF THE CONTRACT. DAID 10% FEE SHALL BE CALCULATED AND PAID ON "OVER-HEAD" COSTS AS WELL AS ON ACTUAL COSTS. ALL RECOGNIZABLE COSTS SHALL BE AS DEFINED IN ARTICLE 5, HEREOF.

ARTICLE 5. COSTS TO BE REIMBURSED.

THE OWNER, EXCEPT AS LIMITED BY ARTICLE 3, HEREOF, AGREES TO REIMBURSE THE CONTRACTOR IN CURRENT FUNDS ALL COSTS NECESSARILY INCURRED FOR THE PROPER PROSECUTION OF THE WORK AND PAID DIRECTLY BY THE CONTRACTOR, SUCH COSTS TO INCLUDE THE FOLLOWING ITEMS, AND TO BE AT RATES NOT HIGHER THAN THE STANDARD PAID IN THE LOCALITY OF THE WORK EXCEPT WITH PRIOR CONSENT OF THE OWNER:

(A) ALL LABOR DIRECTLY ON THE CONTRACTOR'S PAYROLL;

(B) MATERIALS, SUPPLIES, CONSUMABLE EQUIPMENT AND TRANSPORT-ATION REQUIRED FOR THE PROPER EXECUTION OF THE WORK.

(C) THE AMOUNTS OF ALL SUBCONTRACTS, PROVIDED, HOWEVER, THAT ALL SUBCONTRACTS SHALL HAVE BEEN GIVEN OWNER'S WRITTEN APPROVAL PRIOR TO AWARD BY CONTRACTOR.

(D) PREMIUMS ON ALL INSURANCE POLICIES AND BONDS REQUIRED, OTHER THAN STATUTORY PUBLIC LIABILITY AND WORKMEN'S COMPENSATION INSURANCE, IF REQUIRED BY OWNER UNDER TERMS OF ARTICLE 2, HEREOF, THE PRORATA OF STATUTORY INSURANCE COSTS AS APPLIED TO THIS PRO-JECT, AND THE AMOUNTS OF STATURORY TAXES ON PAY ROLLS.

(E) PERMIT FEES, ROYALTIES, DAMAGES FOR INFRINGEMENT OF PATENTS, AND COSTS FOR DEFENDING SUITS THEREFOR AND FOR DEPOSITS LOST FOR CAUSES OTHER THAN THE CONTRACTOR'S NEGLIGENCE. (F) LOSSES AND EXPENSES, NOT COMPENSATED BY INSURANCE OR OTHERWISE, SUSTAINED BY THE CONTRACTOR IN CONNECTION WITH THE WORK, PROVIDED THEY HAVE RESULTED FROM CAUSES OTHER THAN THE FAULT OR NEGLECT OF THE CONTRACTOR. SUCH LOSSES SHALL INCLUDE SETTLEMENTS MADE WITH THE WRITTEN CONSENT AND APPROVAL OF THE OWNER. NO SUCH LOSSES AND EXPENSES SHALL BE INCLUDED IN THE COST OF THE WORK FOR THE PURPOSE OF DETERMINING THE CONTRACTOR'S FEE, BUT IF, AFTER A LOSS FROM FIRE, FLOOD OR SIMILAR CAUSE NOT DUE TO THE FAULT OR NEGLECT OF THE CONTRACTOR, HE BE PUT IN CHARGE OF RECONSTRUCTION, HE SHALL BE PAID FOR HIS SERVICES A FEE PROPORTIONATE TO THAT NAMED IN ARTICLE 4, HEREOF.

(C) MINOR EXPENSES, SUCH AS TELEGRAMS, TELEPHONE SERVICE, EXPRESSAGE, AND SIMILAR PETTY CASH ITEMS.

(H) OVERHEAD EXPENSE, WHICH SHALL BE DEFINED AS EMBRACING ALL COSTS OTHER THAN THOSE NAMED IN PARAGRAPHS (A) TO (G), INCLUS., HEREINABOVE; WHICH OVERHEAD EXPENSE SHALL BE ARRIVED AT AS CONSTI-TUTING THE GENERAL EXPENSE OF THE CONTRACTOR IN THE EXECUTION OF THE PROJECT BY MEANS OF CALCULATING AND ADDING TO SAID COSTS (A) TO (G), INCLUSIVE, FIVE PERCENTUM (5%) OF ALL SAID COSTS.

ARTICLE 6. COSTS NOT TO BE REIMBURSED.

REIMBURSEMENT OF EXPENSES TO THE CONTRACTOR SHALL NOT INCLUDE ANY OF THE FOLLOWING:

(A) SALARY OF THE CONTRACTOR OR OF ANY PERSON EMPLOYED IN CONTRACTOR'S MAIN OFFICE OR OF ANY PERSON EMPLOYED AS A GENERAL SUPERINTENDENT OF THE GENERAL BUSINESS OF THE CONTRACTOR.

(B) INTEREST ON CAPITAL EMPLOYED EITHER IN PLANT OR IN EX-PENDITURES ON THE WORK.

ARTICLE 7. DISCOUNTS, REBATES, REFUNDS.

ALL DISCOUNTS, REBATES AND REFUNDS, AND ALL RETURNS FROM SALE OF SURPLUS OR SALVAGED MATERIALS, ETC., SHALL ACCRUE TO THE OWNER, AND THE CONTRACTOR SHALL MAKE PROVISIONS SO THAT THEY MAY BE SECURED.

ARTICLE 8. CONTRACTOR'S FINANCIAL RESPONSIBILITY.

ANY COST DUE TO THE NEGLIGENCE OF THE CONTRACTOR OR HIS SUB-CONTRACTORS OR ANYONE DIRECTLY EMPLOYED BY HIM, EITHER FOR THE MAKING GOOD OF DEFECTIVE WORK, DISPOSAL OF MATERIALS WRONGLY SUP-PLIED, MAKING GOOD OF DAMAGES TO PROPERTY, OR EXCESS COSTS FOR MATERIALS OR LABOR, OR OTHERWISE, SHALL BE BOFNE BY THE CONTRACTOR, AND THE OWNER MAY WITHHOLD MONEY DUE THE CONTRACTOR TO COVER ANY SUCH COST ALREADY PAID BY HIM AS PART OF THE COST OF THE WORK.

THIS ARTICLE SUPERSEDES THE PROVISIONS OF ARTICLES 13, 19 AND 20 OF THE GENERAL CONDITIONS OF THE CONTRACT SO FAR AS THEY ARE INCONSISTENT HEREWITH.

ARTICLE 9. SUB-CONTRACTS.

ALL PORTIONS OF THE WORK THAT THE CONTRACTOR'S ORGANIZATION HAS NOT BEEN ACCUSTOMED TO PERFORM OR THAT THE OWNER MAY REASON-ABLY DIRECT, SHALL BE EXECUTED UNDER SUBCONTRACTS AWARDED BY THE CONTRACTOR TO PERSONS OR FIRMS AND IN AMOUNTS SUBJECT TO THE AP-PROVAL OF THE OWNER. THE CONTRACTOR SHALL ENTER AND ASSUME FULL RESPONSIBILITY FOR ALL SUCH SUBCONTRACTS AND SHALL PAY ALL COSTS THEREBY PROPERLY IN-CURRED, AS PROVIDED UNDER PARAGRAPH (C) OF ARTICLE 5, HEREOF, AND SHALL MANAGE AND CONTROL THE WORK UNDER ALL SUBCONTRACTS THE SAME AS IF IT WERE HIS OWN WORK, AS PROVIDED HEREUNDER.

ARTICLE 10. TITLE TO THE WORK.

THE TITLE OF ALL WORK COMPLETED AND IN COURSE OF CONSTRUCTION AND OF ALL MATERIALS ON ACCOUNT OF WHICH ANY PAYMENT HAS BEEN MADE SHALL BE IN THE OWNER.

ARTICLE 11. ACCOUNTING, INSPECTION, AUDIT.

THE CONTRACTOR SHALL CHECK ALL MARERIALS AND LABOR ENTERING INTO THE WORK AND SHALL KEEP FULL, DETAILED AND COMPETENT ACCOUNTS SUCH AS MAY BE NECESSARY TO PROPER FINANCIAL MANAGEMENT, SHALL AFFORD # ACCESS TO SAME TO THE ARCHITECT AND TO OWNER'S AUDITOR, IF SO REQUIRED, AND SHALL PRESERVE ALL SUCH RECORDS FOR A PERIOD OF TWO YEARS AFTER THE FINAL PAYMENT HEREUNDER.

ARTICLE 12. APPLICATIONS FOR PAYMENT, CERTIFICATES.

THE CONTRACTOR SHALL, THE EEARLY PART OF EACH MONTH, DELIVER TO THE ARCHITECT A STATEMENT SHOWING IN COMPLETE DETAIL ALL MONIES PAID OUT BY HIM ON ACCOUNT OF THE COST OF THE WORK DURING THE PREV-IOUS MONTH FOR WHICH HE IS TO BE REIMBURSED BY THE OWNER UNDER ARTICLE 5, HEREOF; AS GOVERNED BY ARTICLE 3, HEREOF.

THE ARCHITECT SHALL PROMPTLY CERTIFY TO THE OWNER, EXCEPT AS LIMITED BY ARTICLE 3, HEREOF, SUCH APPLICATIONS AS APPROVED BY ARCHITECT AND SUCH CERTIFICATES SHALL BE PAYABLE BY OWNER ON ISSUANCE.

THESE PERIODICAL STATEMENTS MAY INCLUDE OVERHEAD EXPENSE, AS PROVIDED IN PARAGRAPH)H) OF ARTICLE 5, HEREOF, BUT THE FEE PRO-VIDED IN ARTICLE 4, HEREOF, SHALL BE HELD AS A RETAINER BY OWNER UNTIL FINAL COMPLETION AND THEN PAID; ALL SUCH PAYMENTS OF ALL KINDS BEING MEANTIME HELD SUBJECT TO THE PROVISIONS OF ARTICLE 3, HEREOF.

ARTICLE 13. DISBURSEMENTS.

Should the Contractor neglect or refuse to pay, within five days after it falls due any rill legitimately incurred by him hereunder (and for which he is to be reimbursed under Article 5, hereof) the Owner, after giving the Contractor 24 hours' written notice of his intention to do so, shall have the right to pay such bill directly, in which event such payment shall not, for the purpose either of reimbursement or of calculating the Contractor's fee, be included in the cost of the work.

FLOOR THE CLASS ROOM HOW PROP .

ARTICLE 14. TERMINATION OF THE CONTRACT.

(THE PROVISIONS OF THIS ARTICLE SUPERSEDE ALL OF ARTICLE 22 OF THE GENERAL CONDITIONS OF THE CONTRACT EXCEPT THE FIRST SENTENCE.)

IF THE OWNER SHOULD TERMINATE THE CONTRACT UNDER THE FIRST

SENTENCE OF ARTICLE 22 OF THE GENERAL CONDITIONS OF THE CONTRACT, HE SHALL REIMBURSE THE CONTRACTOR FOR THE BALANCE OF ALL PAYMENTS MADE BY HIM UNDER ARTICLE 5, HEREOF, PLUS A FEE COMPUTED UPON THE COST OF THE WORK TO DATE AT THE RATE OF PERCENTAGE NAMED IN ARTI-CLE 4, HEREOF, AND THE OWNER SHALL ALSO PAY TO THE CONTRACTOR FAIR COMPENSATION, EITHER BY PURCHASE OR RENTAL, AT THE ELECTION OF THE OWNER, FOR ANY EQUIPMENT RETAINED. IN CASE OF SUCH TERMINATION OF THE CONTRACT THE OWNER SHALL FURTHER ASSUME AND BECOME LIABLE FOR ALL OBLIGATIONS, COMMITMENTS AND UNLIQUIDATED CLAIMS THAT THE CON-TRACTOR MAY HAVE THERETOFORE, IN GOOD FAITH, UNDERTAKEN OR INCURRED IN CONNECTION WITH SAID WORK AND THE CONTRACTOR SHALL, AS A CONDI-TION OF RECEIVING PAYMENTS MENTIONED IN THIS ARTICLE, EXECUTE AND DELIVER ALL SUCH PAPERS AND TAKE ALL SUCH STEPS, Ø INCLUDING THE LEGAL ASSIGNMENT OF HIS CONTRACTUAL RIGHTS, AS THE OWNER MAY REQUIRE FOR THE PRUPOSE OF FULLY VESTING IN HIM THE RIGHTS AND BENEFITS OF THE CONTRACTOR UNDER SUCH OBLIGATIONS OR COMMITMENTS.

ARTICLE 15. THE SPECIFICATIONS AND AMOUNT OF WORK.

THE FOLLOWING IS AN ENUMERATION OF THE PRINCIPAL AMOUNTS OF WORK TO BE DONE HEREUNDER, FOLLOWED BY SPECIFICATIONS IN DETAIL FOR THE EXECUTION THEREOF:

(A) STRUCTURAL CHANGES: IN THE THIRD OR TOP STORY OF THE RELIGIOUS EDUCATION BUILDING CERTAIN PLASTERED STUD WALL PARTITIONS SHALL BE BUILT NEW AND OTHERS REMOVED AND/OR REBUILT AS SHOWN ON BLUE PRINT. THE WINDING OR CIRCULAR PORTION OF THE FLIGHT OF EAST STAIRWAY FROM FIRST TO SECOND FLOORS SHALL BE REMOVED, A LANDING BUILT, AND A NEW NORTH-SOUTH UPPER FLIGHT BUILT TO TERMINATE ON SECOND FLOOR; THIS REQUIRING CUTTING THROUGH WALL AND THE "CASING" OF SOFFITT OF CHANGED FLIGHT WHERE SHOWING IN CLASS ROOM BELOW. THE FLIGHT OF STAIRS FROM SECOND TO THIRD FLOORS SHALL HAVE THE PLATFORM LEVEL REMOVED WHICH NOW FINISHES ABOVE THIRD FLOOR LEVEL, THE TOP FLIGHT OF SAME SHALL BE REBUILT TO EQUALIZED RISERS, AND THE FALSE BEAM ACROSS UNDER ATTIC FLIGHT WHICH NOW INTERFERES WITH HEADROOM BELOW SHALL BE REMOVED AND THE ATTIC FLIGHT REFRAMED WITH NEW "STRINGERS" UP FROM SECOND FLOOR FOR GOOD HEADROOM. THE NET RESULT OF THESE CHANGES BEING INTENDED TO GIVE FREE AND COMFORT-ABLE TRAVEL FOR ENTIRE EAST STAIRWAY AND A CONTINUOUS HALL IN THIRD FLOOR FROM SAME TO WEST STAIRWAY, WITH CLASS ROOMS EITHER SIDE, AR-RANGED AS SHOWN ON DRAWING.

IN THE BASEMENT OF GROUND FLOOR THE CLASS ROOM NOW PRO-JECTING WEST INTO ASSEMBLY ROOM SHALL BE REMOVED, ALSO THE PARTI-TION AT EAST END OF SAME, AND A NEW PARTITION TO MATCH EXISTING SHALL BE BUILT ACROSS FLUSH WITH SOUTHEAST CLASS ROOM WALL, WITH SINGLE DOOR, LEAVING ASSEMBLY ROOM WITH STRAIGHT WALL TERMINAL AT EAST END.

INCIDENTAL TO THIRD FLOOR CHANGES ABOVE CALLED FOR AND SHOWN ON DRAWINGS, EACH CLASS ROOM, NEW AND EXISTING, SHALL BE LEFT PROVIDED OR NEWLY PROVIDED WITH A LIGHTING FIXTURE TO MATCH THE EXISTING, WITH SWITCH OR PULL CHAIN CONTROL AS DIRECTED, AND THE NEW HALL SHALL BE AMPLY LIGHTED AND SWITCH CONTROLLED, WITH FIX-TURES PROVIDED, TO MATCH EXISTING.

RADIATION IN THIRD FLOOR SHALL BE REARRANGED OR NEWLY EQUIPPED AND PIPED TO PROVIDE ADEQUATE RADIATION TO EACH UNIT OF SUBDIVISION.

ALL OF THIS WORK SHALL BE PLASTERED IN FINISH TO MATCH



Following is a report of the findings and recommendations of the Committee appointed by Dr. Dandridge with respect to the advisabidity of adopting a plan for the botation of the Vestry and to determine whether or not the present size of the Vestry & Council should be changed.

It is our recommendation that the following plan be submitted to the Congregational meeting in January 1939 for their approval or disapproval:

Said plan, if approved by Acongregation, to become effective in January, 1940.

1. That the Vestry be reduced to 18 men.

2. That the council be reduced to 12 men.

3. That at the congregational meeting to be held in January 1940 six Vestrymen be elected for a period of three years (those six receiving the greatest number of votes to be those selected for 3 years);

That six Vestrymen be elected for a period of two years (those receiving the next highest number of votes being elected for the two year period);

That the six Vestrymen receiving the lowest number of votes be elected for a one year period.

4. That at the expiration of the term of each vestryman he be ineligible for re-election for a period of one year.

5. That this plan apply to the entire vestry, including officers thereof.

This plan has the unanimous approval of your committee and it is suggested that it be given the approval of the Vestry and that the vestry recommend its adoption to the next congregational meeting.
