The Vestry of Christ Church met on Monday, February 20, 1978, at 5:15 in the Wheeler Room.

Members present: Marion Arnold, Glenn Bowron, Bob Brandt, Jim Burns, Owsley Cheek, Bill Coke, Sally Cook, Janet Davies, Merle Emery, John Kiser, Bill Koch, George Paine, Pete Robinson, Catherine Snell, Bill Stockard, Sally Thomas, Speed Thomas, Bob Thomson and Cecil Wray.

Clergy present: Dr. Eric Greenwood, the Rev. Bill Smith and the Rev. Larry Carden.

Dr. Greenwood opened the meeting with prayer.

- 1. The Rector explained that the first hour of the meeting would be spent informing members about the recent Vestry Conference; becoming acquainted with the task force structure to be used this year; giving vestry members an opportunity to sign up for the task force of their choice so that the task forces can be formed by the next meeting.
- 2. The Senior Warden, Bill Coke, read through the Vestry Conference Report and called upon various members to read the task force reports which had evolved during the conference.
- 3. It was decided that plans for our 150th Anniversary Celebration would begin at the next meeting.
- 4. Dr. Greenwood:
 - a. welcomed the new vestry members and introduced the new vestry officers.
 - b. commended the Clerk of the Vestry for the Vestry Conference Report.
- 5. The Assistant, Bill Smith, consented to prepare papers to be passed around so that members might sign up for the task force of their choice.
- 6. Dr. Greenwood read a resolution memorializing Lewis Pride. The resolution was unanimously adopted. Copies of the resolution will be included in the Minute Book of the Parish and sent to Mr. Pridess wife and family.
- 7. The Senior Warden read a letter from Peter Fyfe in which he expressed his gratitude for the increase in the Liturgy budget for 1978-79.
- 8. The Treasurer, Glenn Bowron, presented his report which was approved.
- 9. The Rector reported that:
 - a. he was encouraged by the attendance since the beginning of Lent.
 - 1.) the young people's Shrove Tuesday Pancake Supper was a happy time.
 - 2.) the four celebrations on Ash Wednesday were well attended (about 250 persons) with the largest congregations at 12:15 and 5:15 p.m.
 - 3.) the Wednesday evening Lenten program had begun last week and will continue form more weeks.

- b. there is an occasional need for chalice bearers at Christ Church when some of the clergy must be away. The Rector asked for the consent of the vestry to request Bishop Sanders to license Jim Burns and Bob Smyth as chalice bearers during 1978. The vestry approved.
- 10. Disposition of the Easter Offering was discussed. It was decided that the offering be divided between <u>Meals on Wheels</u> and the <u>Fund</u> for the <u>Restoration of Canterbury Cathedral</u>.
- 11. Dr. Greenwood:
 - a. announced that the Rev. Larry Carden will be ordained to the priesthood at Christ Church on Thursday, March 9, 1978, at 7:30 p.m.
 - b. reported that he had received a letter from Christ Church Archivist, Fletch Coke (Mrs. William G.) in which she asked for approval to submit the name of Christ Church in nomination to the National Register of Historic Places. The vestry approved. She also said:
 - 1.) that ten historic volumes from Christ Church had been placed in the Tennessee State Library and Archives, manuscript section.
 - 2.) that many newspaper clippings about Chriest Church are being placed in chronological order in preparation for them to be put on microfilm and become a part of the permanent records of the State Library.
 - 3.) that Historic Nashville, Inc. and the Urban and Regional Ministry, in cooperation with 12 downtown churches, will be sponsoring tour days at these churches during April and May.
 - c. said that vestry members will bery likely benefit in their leadership roles by reading <u>The Episcopalian</u>. Members were given an opportunity to sign up for a subscription.
- 12. Speed Thomas and Bill Koch were nominated to membership in the EDC. They were unanimously elected.
- 13. Bill Stockard, Property Chairman, reported that a small hole in the ceiling of the church had been repaired.
- 14. Bill Koch mentionedt that the EYC wants to send a representative to address the vestry. It was agreed that an EYC representative would be welcome.

There being no further business, the meeting concluded with a prayer from the Rev. Bill Smith.

Please, find attached the nomination form completed on Christ Church to the National Register of Historic Places. In addition to the form are the write-ups for the Description and the Significance of the church. On your approval, these will be submitted for review and editing to the Tennessee Historical Commission, the state agency in charge of the nomination of all state properties to the National Register. The bibliographical references used in the footnores were all Xerox'd from original records with the exception of the 1929 Centennial book and Mr. Stokes booklet (I lent my copies of these two rather than Xerox). We will receive the Xerox'd copies back and these will be a nice addition to our Archivessince we can trust these original records to be accurate !

To quote from the <u>Nashville Tennessean</u>, January 31, 1978, in an article about buildings being nominated to the National Register on the Fisk University campus:

The listing of a building in the Register signifies that the structure is worthy of preservation although inclusion does not guarantee that a building will not be torn down. However, buildings listed are afforded a measure of protection by statutes that require hearings be held and review procedures instituted before any federally-funded project that might endanger a historic site. Listed buildings also are eligible for matching grants from the Department of the Interior for restoration and renovation. More than 400 Tennessee sites now are included in the National Register and 20 of those have been designated national historic landmarks.

In Nashville, however, there are only four churches listed on the National Register: St. Mary's, Downtown Presbyterian, Holy Trinity and Church of the Assumption.

You have received from me the list of the ten historic volumes placed on deposit from Christ Church in the Tennessee State Library and Archives, Manuscript Section.

I have asked the Manuscript staff what can be done about the reams of newspaper clippings that provide such a wealth of imformation about our church, ministers, the diocese and related subjects. The life expectancy of newspaper clippings is not forever and gradually these will deteriorate. I have been told that if we put these clippings in chronological order that they can be copied on microfilm and thus become a part of the permanent records of the State Library- conserved and also available to scholars and researchers. Marjorie Cummins is working with me on this project.

In looking for a rare and important book in the Hotchkiss Library, I realized when I did not find the book on the shelf that perhaps thought should be given to removing the more valuable books from such an accessible place. We have several competent librarians in the parish who could doubtless be enlisted for this study.

CHRIST CHURCH

DESCRIPTION

Positioned at a corner in Nashville's downtown area, Christ Church's robust Gothic assymmetry can be admired from several angles. A rectangular tower of open-work stone tracery projects upward from the corner of the heavily rusticated building. The tower and surface details of smooth Bowling Green stone make for a lively contrast with the major portion of the building which is of Sewanee sandstone. At the base of the tower tiered-arched portals are accented by menacing gargoyles between corner buttresses. A large rose window dominates the centrally positioned gable of the facade. The acutely angled pinnacle formed by the gable is filled with a pseudo-lancet window and topped by simple crockets and a prominent cross-shaped filial. Of English influence, Christ Church is one of the finest examples of Victorian Gothic architecture in Nashville. (1)

The sandstone used in the construction of the church was a gift from the University of the South at Sewanee, Tennessee. The stone work was carried out by the Nashville firm of Dennedy and Maddox. (2) The tower was not completed until 1947. The Vestry communicated with the New York firm of the original architect, Francis Hatch Kimball. The firm recommended Russell Hart, Nashville architect, who executed the design from the detailed drawings and supervised the construction. The Nashville Stone Setting Company was in charge of the stone work. The tower was built by a fund, started in 1929, which was completed by a gift of the grandchildren of Albert B. Payne who had served on the building committee in 1890 for the new church. In 1949, through a gift of Louise Bransford McGavock, the chimes were installed in the tower. (3)

Francis Hatch Kimball began his architectural career in Boston during 1867. In 1873, he was selected as the supervising architect for the buildings to be erected at Trinity College in Hartford, Connecticut, designed by London architect William Burgess. Mr. Burgess, a well-known exponent of the French Gothic, was visiting America at the time. During this period, Mr. Kimball spent several months in England studying Gothic architecture. In 1879, Mr. Kimball opened an office in New York City where he was commissioned for a wide variety of buildings, including theatres, town and country residences, railroad stations and many beautiful churches. (4)

In 1886, the Christ Church Vestry approved the plans for the new chapel and church designed by Francis Hatch Kimball. (5) For the chapel, W.C. Smith, Nashville, served as the supervising architect and for the church, B.J. Hodge served as the local architect. (6) The chapel was completed in 1888, and the church was completed in 1894.

The sanctuary of Christ Church has a distinctive early English atmosphere. Spanning the central nave is a tunnel vault of dark oak braced by tremendous tie-beams. The interior extends to either side forming a Greek cross floor-plan. Dividing the vault from the rounded gores to each side is a banded, slightly pointed arcade supported by granite columns with foliated capitals. Above are the clerestory windows, a series of triplets with two small columns within each group. Lining the side aisles are small rosette and lancet windows. The light from the wall openings counters the deep tones of the massive carved woodwork within the sanctuary. Other interesting architectural features are the Victorian bay window emcompassing the baptismal font at Christ Church Description Fage 3

the northwest corner and the small self-contained chapel beyond the southeast side aisle. (7)

Christ Church has many fine stained glass windows. The beautiful rose window was a memorial to Jane Smith Washington, given by her children. In the east clerestory, the second group of lancet windows are a memorial to the three children of Mr. and Mrs Leslie Warner. The windows were designed by Louis Comfort Tiffany and required a year for execution. The third group of lancet windows in the west clerestory were also designed by the Tiffany Company and were given in memory of Mrs. John C. Brown by her son. (8) The Resurrection windowsabove the altar were given as memorials. The central window was given in memory of George Augustine Washington by his widow Jane. The inscription in the glass reads "Born May 24, 1815 - Died December 4, 1802." Mr. Washington died in 1892. Here is an example of the mischief of artisans so often seen in European cathedrals. (9)

The focal point of the sanctuary is the handsome wood carved altar piece with the bronze plaque of the crucifizion in the middle of the altar. Melchoir Thoni, a Swiss emigrant, employed at the Edgefield and Nashville Manufacturing Company, is credited with supervising and personally carving the altar, the pulpit, the communion table and the chair rail. (10) The unusual angel lecturn, made of solid bronze, was the work of Silas McBee(11) The baptismal font of Sicilian marble was made for the first Scottish International Exhibition in 1886, and was a gift of a former rector, Dr. William Graham, to the congregation in 1889. (12) The baptistery also has an immersion pool, the only known Episcopal church in the area with such a pool. The pews were carved by the Nashville firm Christ Church Description Page 4

of Simmons, Phillips and Hawthorne. (13) All the furnishings described for the church were the gifts of two women's organizations, the Parish Aid Society and the Kensington Circle. (14) In 1894, Christ Church purchased a Farrand and Votey organ, the finest organ available and at the time of installation the only one of its kind in the south. It was an electro-pneumatic organ. In 1940, the organ was enlarged to 2,438 pipes and chimes. A new console was added in 1957, and in 1959, the organ was dedicated to F. Arthur Henkel, organist at Christ Church for over fifty years. (15)

In 1956, Christ Church undertook a \$300,000, remodelling program to build new classrooms and a dining room by excavating under the sanctuary and to remodel the parish hall, the 1888 chapel, and connect it to the main church. This extensive building program was successfully completed in 1959. Edwin A. Keeble, Nashville, served as the architect, and W.F. Holt & Son as the construction contractor. (16)

CHRIST CHURCH

SIGNIFICANCE

Christ Church, located ten blocks from the Tennessee State Capitol, was built in what was a residential neighborhood in the 1890's, on the corner of Broad and McLemore (now Ninth Avenue North) in downtown Nashville. The church was built between 1890 and 1894, and first worship services were held on December 16, 1894. (1) Christ Church was organized as the first Episcopal parish in Nashville and Davidson County and as one of the first three in the Diocese of Tennessee. The present church is their second house of worship in downtown Nashville. On Broad, two blocks west is Union Station, a National Historic Landmark, and one block east on Broad, the Customs House and Hume-Fogg High School, both listed on the National Register of Historic Places.

In 1779-1780, the western territory along the Cumberland River called "the Bluffs" was settled mainly by Scotch-Irish pioneers. During the early years the settlers at Fort Nashborough contended with the ever present menace of Indian attack and survival, leaving no time for the development of organized churches. By 1787, the Methodists were meeting and by 1789 were building a church on the public square. In 1814, the Presbyterians and in 1820, the Baptists were starting their first churches in Nashville, It was not until 1825 that James H. Otey came to Tennessee to establish the Episcopal church. He began his work in Franklin and Columbia, and by 1825, he was holding meetings at the Masonic Hall in Nashville. (2)

On June 29, 1829, at the Masonic Hall, the congregation of Christ Church met and elected the first Vestrymen, Thomas Claiborne, Francis B. Fogg, Dr. John Shelby, James Stewart and Henry Baldwin, Jr. These five men dominated the growth of the church during the early years. (3) On September 2, 1829, the

Vestry resolved to purchase a lot on the corner of Church and High (now Sixth Avenue North), belonging to Mr. Stewart for \$2,400. The building committee composed of Claiborne, Shelby and Stewart, were authorized to obtain proposals for the building and superintend the erection of the church. (4) Five months later George Weller was elected Rector of Christ Church and his first duty was to direct to Nashville the shipment of the new organ purchased in Philadelphia. (5) The parish was assisted in procuring the salary for the new rector from the Domestic and Foreign Missionary Society of the Protestant Episcopal Church which was concerned with "the growth of the church in the west."(6)

In March, 1830, the Vestry issued invitations to the only other two Vestries in the Diocese of Tennessee, located in Franklin and Columbia, to participate in the laying of the cornerstone for the new church. (7) The cornerstone was laid, at this the first Episcopal church building in Tennessee, on July 5, 1830. The names of the rector, the Vestry, the architect Hugh Roland and the builder William Shields, were written on a scroll and placed along with the Bible and the Prayer Book in a box within the cornerstone (8) Services were continued at the Masonic Hall until the church was completed. Even during this period, music was important to the church members. James Diggons served as the choir leader and the congregation was using the first church organ in Nashville. (9) The Gothic styled stone church, with a sanctuary measuring 45 by 60 feet, containing 62 pews, was completed in 1831. The church had cost \$16,000. An impressive ceremony was conducted by Assistant Bishop Meade of Virginia for the consecration of the church on July 6, 1831. (10) During this historic visit to

Middle Tennessee, Bishop Meade also laid the cornerstone for St. Peter's Church in Columbia and presided at the third convention of the Diocese of Tennessee. (11)

At the time the church was completed, Rev. Weller reported 34 communicants. (12) On July 9, 1831, the pews of the church were auctioned, the lowest price given was \$60.00, and the highest price was \$182.00, paid by Francis B. Fogg. (13) The sale of the pews assisted in reducing the heavy debt incurred in the erection of the church. (14) In 1833, the Vestry resolved that each pew holder was entitled to one vote at the parish meetings. The sale of pews continued until 1918, when the pews were declared "free and open to all." (15) By 1838, the church had grown to 72 communicants and 152 pupils in the Sunday School with 18 teachers. (16) By the outbreak of the Civil War, Episcopalians had grown so numerous in Nashville that Christ Church had helped to establish two other Episcopal churches in the downtown, Church of the Advent and Holy Trinity. (17)

At the first Vestry meeting on June 29, 1829, three delegates were elected to attend the convention which would take place in Nashville that July. The Diocese of Tennessee was organized on July 1, 1829, at this convention which was held at the Masonic Hall. Bishop John Ravenscroft of North Carolina presided over the meeting which was composed of three clergymen and six lay delegates. The diocese would be under the supervision of North Carolina for the next four years. (18) In September, 1830, the Vestry of Christ Church voted to accept the articles of association recommended at the convention. (19) Christ Church, as the mother church of the diocese, has continued to support the work at the

diocesan level throughout her history. (20) Christ Church was the site of a number of early religious events. Here on July 6, 1831, Bishop Meade held the first confirmation services in a consecrated church in Tennessee. On July 1, 1832, the first ordination of an Episcopal clergyman in the state was held in Christ Church with Bishop Ives of North Carolina presiding. The clergyman was John Chilton. (21)

During the Civil War, the Confederate Army withdrew from Nashville and the city was surrendered in February, 1862. The city would be occupied by the Federal Army for the next three years until the end of the war. Curfew, censorship of the press, occupation of private homes and churches were the unpleasant realities of the occupation to Nashvillians. Most of the members of Christ Church were supporters of the Confederate cause, yet Francis B. Fogg, a Union man, continued to serve as the Senior Warden during those terrible war years. (22) Christ Church was one of the few churches in Nashville not demolished or injured by the Federal troops during this period. Various reasons have been advanced for this escape, such as the windows of dark red and ochre glass made the building useless as a hospital and the fact that many Federal officers. occupying the city, were Episcopalians. (23) The doors of the church were kept open by the Rev. Harlow, of Holy Trinity, a church occupied by the Federal troops. Through the efforts of Rev. Harlow and the ladies of the church, Christ Church was at times the only church in the city holding regular services. (24) In Tennessee elected delegates had continued to attend conventions of the diocese through the first two years of the war. At the close of the war, the diocese was without a bishop, Bishop Otey having

died in Memphis in 1863. The standing committee called a special meeting of the Diocesan Convention to meet at Christ Church in September, 1865. Sixteen clergymen and fifteen lay delegates gathered and proceeded with the election of a new bishop, Charles Todd Quintard. F.B. Fogg, G.M. Fogg and C. Carvill represented Christ Church. (25) During the meeting of the General Convention in Philadelphia in October, 1865, Dr. Quintard was consecrated the second bishop of Tennessee. The fact that bishops from north and south took part in this convention was a sign of the unity of the Episcopal Church. (26)

When Rev. Ellis arrived as the new rector of Christ Church in 1866, he found less than one hundred communicants. But his report to the convention one year later indicated favorable conditions with all pews sold and the need for more room. (27) It would be almost 20 years later before the Vestry resolved to build a new church. In November, 1883, the Vestry authorized the purchase of a lot on the corner of Broad and McLemore, measuring 89 by 160 feet, for \$15,000. (28) Three years later the Vestry resolved that the plans for the church and chapel, as presented by Architect Kimball of New York, be accepted and adopted. The building committee reported that the cost of the chapel would be \$15,875, and for the church \$40,637. (29) The final cost of the two buildings would double the original estimates. The oldchurch was sold for \$5,800, on January 27, 1890. First Sunday School services were held in the new chapel on October 28, 1880, and shortly thereafter, on July 14, 1890, groundbreaking ceremonies were held for the new church site. (30) In 1891, the bell from the old church was rehung in the belfry of the new chapel. The bell, cast in Philadelphia by John Wilbank

in 1831, is the physical link between the old church and the present Christ Church. (31) On September 7, 1892, the cornerstone, weighing 5,555 pounds and stating "Christ Church A.D. 1830-1892" was laid by the Bishop of Tennessee. (32) Then Nashville passed through the worst financial depression of her history. With difficulty the Vestry borrowed the necessary \$20,000, to finish the building. (33) On December 16, 1894, first services were held in Christ Church with the two bishops from Tennessee, Bishop Quintard and Bishop Gailor, presiding. (34)

Christ Church has served as the training ground for future bishops. James H. Otey, who had established the first Episcopal churches in Tennessee including Christ Church, was consecrated the first Bishop of Tennessee in 1834. (35) After serving as rectors at Christ Church, eight men have become ordained bishops, two of them in Tennessee and the others in Arkansas, Georgia, Delaware, South Carolina, Atlanta and New York. (36) Christ Church may rightly be called the "School for Bishops." (37)

From the beginning Christ Church was dedicated to establishing missions to serve neighborhoods throughout Nashville and Davidson County. Today in Davidson County, there are twelve active churches which were organized with the guidance and support of Christ Church. Some of these churches were founded as missions long ago such as Holy Trinity where work began in South Nashville in 1849, and St. Anne's in East Nashville in 1858. Others were founded in recent years such as St. George's in West Nashville in 1949, and St. Matthias in 1957. Six other missions, established by Christ Church before 1900, served neighborhoods for shorter periods of time and no longer exist. Thus Christ Church has been active in the establishing of

eighteen missions to spread the Episcopalian faith throughout Davidson County. (38)

Many of Nashville's foremost families were the founders of Christ Church. such as the Rutlege, Washington, Claiborne, Shelby and Fogg families. Men from these families served as members of the Vestry. To describe three of these men will give some idea of the outstanding leaders who served the church. Thomas Claiborne, the first Senior Warden, was also the first Grand Master of the Masonic Lodge of Tennessee. Francis B. Fogg, who served on the first Vestry and served as Senior Warden for twenty-five years, was also a prominent lawyer and a Trustee of the University of Nashville for 57 years. The first high school in Nashville was named for him and today on Broad, one block from Christ Church, stands Hume-Fogg High School. (39) Captain William Driver, a retired sea captain, who named the American flag "Old Glory," served on the Vestry, (40) Over the years, members of Christ Church in the fields of law, the railroads, medicine and education have contributed significantly to their community. The same record of leadership is true today in the church. (41)

Although no women served on the Vestry of Christ Church until 1969, there were other organizations in the church through which women actively worked. One of the earliest and most outstanding was the Parish Aid and Sewing Society. Over the years this Society raised the funds and purchased the church bell for \$600.00, bought the rectory in 1878, gave the Vestry \$15,000 to purchase the new lot on Broad as well as buying the pulpits, alm basins and church furniture. (\$2) In 1891, the Kensington Circle, an organization for young church ladies, raised the money to purchase the new church

pews. (43) Two women of special interest will be mentioned. Mary Middleton Rutledge Fogg, granddaughter of two signers of the Declaration of Independence, was married to Francis B. Fogg. Her works were so worthy in the church that she was called the "mother of Christ Church." Mrs. Fogg was one of the twelve founders of the Parish Aid and Sewing Society in 1829. (44) In more recent years, Mrs. Leslie Warner will serve as an example of church and civic involvement by church women. The Kensington Circle was organized in 1891, by the rector and Mrs. Warner as chairman and leader. Mrs. Warner served as one of the leaders in Nashville in the work for equal suffrage. Her endeavors, along with others, resulted in victory when Tennessee became the 36th state to ratify the Nineteenth Amendment in 1920. (45)

Today Christ Church is making preparations to celebrate the 150th anniversary of the church in 1979. This will be a time not only to celebrate a rich heritage but also to celebrate the fact that Christ Church is still a strong and active church in downtown Nashville. There are over 1100 communicants and the budget for 1978-1979 has been set at \$256,992. Outreach programs are sponsored by the church through contributions of money and volunteers to the Downtown Storefront Ministry, to St. Luke's Community Center and to the Urban and Regional Ministry. Christ Church in co-operation with the Nashville Symphony and other musical groups presents several major musical works to the community throughout the year. Christ Church is one of the major supporters of the Diocese of Tennessee. In 1977, the church contributed \$58,000, to the Diocese. In 1978, Christ Church has increased their gift to \$60,000, (46) Prepared by Fletch Coke, 2/15/78

Members present: Marion Arnold, Glenn Bowron, Bob Brandt, Jim Burns, Bill Coke, Salky Cook, Janet Davies, Merle Emery, John Kiser, Bill Koch, George Paine, Pete Robinson, Catherine Snell, Sally Thomas, Harriet Waller and Cedil Wray.

- I. Everymember Canvass Report:
 - A. George Paine reported that:
 - 1. He, along with the Rector and Senior Warden, had attended a Stewardship Conference.
 - a. He gave each vestry member a copy of a document he had received at the conference and stressed the stated purpose therein regarding the Stewardship Canvass: to stimulate people to a deeper loyalty to Jesus Christ and his Holy Church.
 - B. After discussion and two amendments, the statement drafted last year, regarding the important leadership role of the vestry in the canvass, was adopted for this year.
- II. The minutes were approved as read.
- III. The treasurer's report was received with thanks.
- IV. The Rector reported:
 - A. On the Layman's Conference at DuBose. Owsley Cheek was installed as Keyman for Christ Church.
 - B. Corporate Communion, on September 17, had the largest attendance at 8:00 a.m. service (except for Easter) on record.
 - C. That Glenn Bowron had resigned as Treasurer.
 - 1. The Rector expressed his regret and spoke of Glenn's tremendous contribution to Christ Church in his role as Treasurer. The clerk was asked to send a letter of gratitude to Glenn on behalf of the vestry.
 - D. Announced plans to have the next vestry meeting at St. Luke's on October 23 at 5:15 p.m.
 - E. Said that the loose offering from the second Sunday in September had been given to EDC.
 - F. Announced that the next UTO Ingathering will be Sunday, October 22.
 - G. Announced an EDC Meeting on September 26.
 - H. Said he would be attending an Urban Southern Rector's Meeting on October 16, 17 and 18.
 - V. Reports followed:
 - A. Christian Education Task Force:
 - Don Shriver reported an increased attendance at adult classes.
 a. He said the task force will meet every other month and commented

on the excellent beginning of the church school this year.

- 2. Joyce Paldino expressed pleasure at the positive response of the youth and children to the church school program.
- 3. Bill Smith reported that Joint Youth Ministries will have its first meeting at Christ Church on Sunday, October 1, at 5:00 p.m.

- B. EDC Report:
 - 1. Speed Thomas reported that plans for next EDC meeting included resolutions to consider changing the name to Episcopal Ministries of Middle Tennessee and to procure a media coordinator.
 - 2. Bill Smith announced the Symposium on Ministry to Transients to be held at Christ Church on October 12, from 5:00 to 9:00 p.m.

 - b. Name tags are being made.

 - 3. Larry Carden reported that he would like to have training for additional members of St. Chrysostom's, perhaps including some Vanderbilt students.
- D. 150th Anniversary Task Force:
 - 1. The Senior Warden reported that Bob Smyth will have a meeting soon.
 - 2. John Kiser reported that:
 - a. James Hamilton had submitted a logo to the art committee. Copies were shown to the vestry.
 - b. Dr. Hamilton Hazelhurst had suggested that parishioners be asked to display their art objects on Sundays in the Parish Hall.
 - c. Children's art will be displayed from time to time.
 - d. Consideration was being given to commissioning a relief sculpture for the stairway niche. Suggestions for a possible theme for the sculpture were requested.
- E. Property Committee:
 - 1. Bill Stockard requested authorization to sign the contract submitted by Hauser Studios to restore the stained glass windows for \$34,975.
 - a. He further requested that a total amount of \$38,000 be approved allowing \$3,500 for contingency.
 - b. He said that restoration need not begin for six months if we are willing to pay 10% of the total amount now. (\$3,800)
 - 2. The vestry agreed to adopt a total budget of \$38,000 for the restoration and pay 10% (\$3,800) now.

- I. The first hour of the meeting was devoted to acquainting the vestry with the program and facilities of St. Luke's. Frad Rodgers, Director of St. Luke's, and Shirley Lechleiter, President of the Board of St. Luke's, headed up the program. After a tour of the facilities, the vestry enjoyed supper on the premises.
- II. The business meeting followed supper.
 - A. The minutes were approved as read.
 - B. Every Member Canvass Report:
