Approval of Minutes from February 20, 2012 Meeting (Appendix A)

- Implementation of mission statement including review of committee structure, staff job responsibilities and related areas to ensure coherency of mission and structure
- Hire a communications coordinator
- Installation of new Parish management software
- Host 2013 Annual Diocesan Convention (January 25 26, 2013)
- "Hundred Hands of Mercy" events complimentary to Dean Kimbrough serving on the Board of Nashville CARES
